- ___ Young Adult : \$33.50 monthly/\$381.90 annually (Ages 19-25) *No joining fee
- ___ Adult: \$43.50/\$495.90 annually (Adult age 26-64)
- ___ Adult Couple: \$50 monthly/\$570 annually (Two adults in same household, ages 19-64)
- ___ Family: \$65.00 monthly/\$741 annually (Two adults living in the same household and legal dependents (as defined by the IRS) under the age of 26.)
- ___ Single Parent Family: \$52.00 monthly/\$592.80 annually
- ___ Senior: \$35.00 monthly/\$399 annually (65 years and older)
- ___ Senior Couple: \$48.00 monthly/\$547.20 annually (Two adults in same household, one needs to be 65 or older)

There is a **\$40 membership joining fee** also due at the time of sign-up. The joining fee is waived for youth and young adult memberships. YMCA Membership Service Associates will inform you of your total payment due after entering your information into our membership program. Monthly fees are pro-rated to the date of your first bank draft.

Blair Family YMCA Terms & Conditions

1. In consideration of gaining membership or being allowed to participate in the activities and programs of the YMCA and to use its facilities, equipment and machinery in addition to the payment of any fee or charge, I do hereby waive, release, and forever discharge the YMCA and its officers, agents, employees, representatives, executors, volunteers, and all others from any and all responsibilities or liability for injuries or damages resulting from my or my family's participation in any YMCA activities at said facility or off the facility premises in any way arising out of or connected with my participation in any activities of the YMCA or the use of any equipment of the YMCA.

2. Further, I hereby grant full permission to any and all of the foregoing to use, re-use, publish, and republish the same, in whole or part, individually, or in conjunction with other photographs, in any medium and for any purpose whatsoever, including (but not by way of limitation) illustration, promotion and advertising and trade, television and multimedia and to use my name in conjunction therewith if the YMCA chooses of me participating in any and all YMCA activities and/or events for any publicity and/or promotional purposes without obligation or liability to me.

3. I declare, for any minor(s) and myself that I/he/she/we is/are physically able to participate in the activities of the Blair Family YMCA.

4. I agree to adhere to all policies set by the YMCA as written. I also agree to notify the YMCA of any change in bank information or employment that would affect my payment procedure.

5. Membership cards remain the property of the YMCA and must be surrendered upon request. I understand cards are non-transferrable and that loaning this card may subject the owner to loss of privileges.

6. I understand that a membership category may change due to age or school enrollment status and that this change may affect the membership rate.

7. I understand that any person who supports the YMCA's purpose may become a member of this corporation, in accordance with such provisions as may be established by the board of directors, and shall so continue to be a member unless the Board or its authorized agent concludes in its sole discretion, that a member has failed to live up to the standards and commitments of being a member of this YMCA. The YMCA has the right to terminate my YMCA privileges. The YMCA has the right to terminate YMCA privileges anytime if: it appears that you are taking actions or doing things that are contrary to the YMCA's mission, or it appears that you are involved in criminal acts or you are acting in ways that disrupt the YMCA's operations.

8. The YMCA conducts regular sex offender screenings on all members, participants and guests. If a sex offender match occurs, the YMCA reserves the right to cancel membership, end program participation, and remove visitation access.
